**GENERAL INSTRUCTIONS:**

This Addendum No. 2 ("Addendum No. 2") is being issued subsequent to and as part of the issuance of the City of Rancho Mirage Notice Inviting Sealed Bids for Traffic Signal Interconnect Improvements, Project No. C.P. 13-308-014 and CP 13-308-015, dated August 7, 2019, and the associated Bid Packet containing Contract Documents and Specifications (collectively, "Bid Packet"). All terms capitalized herein shall have the same meaning ascribed to them in the Bid Packet.

The following changes, corrections, and clarifications shall be made a part of the plans, specifications, and contract documents on this project:

The NOTICE INVITING SEALED BIDS, on page 00100-1 of the Bid Packet, is hereby revised so that the **bid opening time and date are changed to 2:00 P.M., on Tuesday, September 17, 2019** as follows:
