Plan Review Submittal Checklist

PLANS AND CALCULATIONS

All inspection requests and questions should be emailed to BuildingDept@RanchoMirageCA.gov. A response will be provided within 48 hours. Inspections shall be performed on Tuesday, Wednesdays, and Thursdays only.

- All plans must be stamped and approved by planning before submitting them to Building & Safety.
- All plans require a grading permit, when over 500 sq. ft., to be submitted to Public Works- Engineering department before submitting to Building & Safety.

RESIDENTIAL

- Two (2) duplicate sets of wet-Signed Plans- Residential (Electric load calculations; Single line HVAC; Electrical diagrams; and plumbing isometrics).
- One (1) Assessor's set Residential. Assessor requires coversheet, site plan, and floor plan; this is a requirement at submittal.
- Two (2) duplicate sets of wet-signed energy calculations (Climate Zone 15).
- Two (2) duplicate sets of wet-signed structural calculations (1 10 MPH Wind Speed, Exposure C).
- Two (2) duplicate sets of wet-signed truss calculations; unless it is a conventionally framed system.
- Letter of Acceptance for Trusses from the Engineer of record.

COMMERCIAL

- Two (2) duplicate sets of wet-Signed Plans-Commercial (Electric load calculations; Single line HVAC; Electrical diagrams; and plumbing isometrics).
- One (1) Assessor's set Commercial. Assessor requires coversheet, site plan, and floor plan; this is a requirement at submittal.
- Two (2) duplicate sets of wet-signed energy calculations (Climate Zone 15).
- Two (2) duplicate sets of wet-signed structural calculations (1 10 MPH Wind Speed, Exposure C).
- Two (2) duplicate sets of wet-signed truss calculations; unless it is a conventionally framed system.
- Letter of Acceptance for Trusses from the Engineer of record.

If installing a pool, spa, and or block walls over 30 inches in height- SEPARATE PERMITS ARE REQUIRED
