<b>GENERAL BUSINESS:</b> Every person engaged in business (retailing, merchandising, wholesaling, manufacturing, processing, distributing, warehousing, or utility services). <b>\$3.00 per employee and/or non-licensed professional working within the City of Rancho Mirage</b>	\$30.00
<b>CONTRACTORS:</b> Any contractor holding a general engineering contracting classification or any general building contracting classification, or specialty contracting classification as those terms defined in Sections 7056-7058 of the Business and Professions Code of the State.	\$89.00
<b>NON-LICENSED BUILDING TRADESMEN</b>	\$75.00
<b>EATING ESTABLISHMENTS AND CATERING SERVICES</b>	\$30.00
<b>CLUBS, PRIVATE, RECREATIONAL:</b> For private clubs at which recreation sport or other facilities provided for members and others.	\$89.00
<b>PROFESSIONAL:</b> "Professional" includes the following: architects, attorneys, certified public accountants, chiropractors, chiropodists, podiatrists, dentists engineers, funeral directors and morticians, surveyors, registered nurses, ophthalmologists, oculists, optometrists, osteopaths, physicians and surgeons, psychiatrists, psychologists, veterinarians, x-ray technicians, stockbrokers, real estate brokers, and real estate agents. <b>Working within the City of Rancho Mirage</b>	\$58.00 per licensed employee
<b>SERVICES:</b> Every person engaged in a service business such as a landscaper, caregiver, gardener, etc. <b>\$3.00 per employee and/or non-licensed professional working within the City of Rancho Mirage</b>	\$30.00
<b>HOTELS, APARTMENTS, COURTS AND ROOMING HOUSES:</b> For the business of renting or leasing any hotel, rooming house, boarding house, apartment house, court or lodging house (three rooms or more) at the rate of \$2.00 per year for each such rooms, with a minimum tax of \$29.00 per year and a maximum of \$177.00 per year.	\$2.00 per room, \$29 min. and \$177 max.
<b>MOBILE HOME PARKS:</b> For the business of renting or leasing spaces for mobile homes and trailers which are used for living purposes or conducting a mobile home park or court for mobile homes or trailers used for living quarters or housekeeping purposes.	\$29.00
<b>MOTOR VEHICLES/DELIVERY:</b> Every person who conducts, manages or carries on the business of running, driving or operating any automobile, truck or other motor vehicle used for the transportation of goods, wares, merchandise or tangible personal property for delivery to any place in the city (other than common carriers not otherwise provided for or specifically mentioned herein).	\$58.00 per vehicle
<b>VEHICLE SERVICE OR MAINTENANCE:</b> For every garage, repair shop, or service station, where motor vehicles are repaired, serviced, or maintained.	\$58.00
<b>PROPERTY MANAGEMENT COMPANY:</b> Management company who manages long term (28 days or more) rental property(ies) on behalf of owners. <b>\$3.00 per employee and/or non-licensed professional working within the City of Rancho Mirage.</b>	\$30.00
